(c) Whether CE (P) can re-appropriate funds upto 25 % of budget estimate on each occasion. | CE (P) can re-appropriate fund under same MH upto 25% of budget estimate subject to ceiling limit of Rs 5 crores in a financial year. However there is no limitation of occasions for re-appropriation of funds within a financial Year. |

RE-APPROPRIATION OF FUNDS WITHIN MAJOR HEAD

1. Chief Engineer has got full powers to transfer funds under Para 576 of BR Regulations against a sanctioned job between the various jobs under same Major Head, Sub Major Head, Minor Head, Sub Head, Detailed Head & same object Head. For eg. funds can be re-appropriated under same object Head of 53 by Chief Engineer among various jobs if allotment has been made against 15 digit classification of MH 5954.02.337.03.00.53.
2. No funds to be transferred to the Jobs where the expenditure exceeds the limit of AA plus the tolerance limit. No expenditure can be incurred on unsanctioned jobs.
3. Further Chief Engineer can also re-appropriate funds up to 25% of Budget Estimate within the Sub Head of Minor Head under the same Major Head subject to a maximum of Rs 5.00 Crore.
4. This issues with the concurrence of PCDA (BR) vide their ID No. BR/Bud/901/Allot/2010-11 dated 05 Dec 2011.
