Subject: Amendment to the BRDB Sanction letter No.BRDB/03/138/2000/GE-I dated 15th December 2008 regarding 'Additional Leave Travel Concession : Grant of Cash in lieu of Single Journey Free Rail Pass'.

Sir,

I am directed to refer to the BRDB Sanction letter No.BRDB/03/138/2000/GE-I dated 15th December 2008 regarding 'Additional Leave Travel Concession : Grant of Cash in lieu of Single Journey Free Rail Pass' and to convey sanction of the President to amend para 2 of the said letter as under:

FOR:

"2. GREF Officers and subordinates are permitted to avail above concession in the form of refund of the value of Single Journey Free Railway Warrant in entitled class at public tariff (Cash in lieu of Single Journey Free Railway Warrant) provided the individual incurred the expenditure on the mode actually adopted and that no extra expenditure of the state is involved."

READ:

"2. GREF Officers and subordinates are permitted to avail above concession in the form of refund of the value of single journey Free Railway Warrant in entitled class at public tariff (cash in lieu of single journey Free Railway Warrant) provided the individual incurred the expenditure on the mode actually adopted and that no extra expenditure of the State is involved. In so far as duty stations located in Andaman & Nicobar Islands or any other Island/group of Islands is concerned, 50% of Ship/Air fare (whichever is lower) in the entitled class for journey from duty station to the Nearest Railway Station (NRS) and back will be refunded."
