

SUB: Admissibility of Bed & Linen Grant

One of the field controller referred an issue regarding lumpsum grant in lieu of supply of Bed & Linen pertaining to Defence Service Officers posted abroad, stating that Defence Service Officers posted with United Nation Missions e.g. MONUSCO etc. are also claiming Bed and Linen Grant referring the authority of MoD letter No. 4(1)/2011/D(Pay/Services) dt. 19.8.2011.

2. The issue was examined at this HQrs in consultation with some of our field controllers and it was opined by the PCsDA/CsDA that the MoD's ID dt. 19.8.2011 is not applicable on UN missions.

3. It also emerged that , ***“since the authority quoted in MoD ID dt. 19.8.2011 is that of MEA order bearing No. Q/GA/7918/08 dt. 31.12.2008, therefore, it should be applicable only for individuals posted in Embassies/Mission under MEA”.***

4. Meanwhile the clarification from MoD on this issue has also been received wherein the MoD has clarified that, ***“orders for payment of lumpsum grant in lieu of supply of Bed & Linen were issued vide MoD letter No. 4(1)/2011/D(Pay/Services) dated 19.8.2011. No further orders have been issued thereafter”.*** (copy of MoD's clarification dt. 12.2.2018 is enclosed).

5. In view of clarification received from MoD and opinion expressed by PCsDA/CsDA, subject case may be dealt accordingly as per Para 3 above.

Subject: Payment of lumpsum grant in lieu of the supply of Bed and Linen from India.

Sir,

In supersession of this Ministry's letter No. CG/0903/NHQ/2523/D(Pay/Services) dated 15 June 1990, I am directed to convey the sanction of President to the payment of a lumpsum grant in lieu of supply of bed and table linen to the entitled Defence Service officers posted in Missions abroad on following basis:-

Heads of Posts and other entitled officers who are equivalent in rank to officers in Grade III and IV of IFS - Rs 22,000/-

2. The grant will be drawn in Indian currency and the officers will become entitled to grant for each posting abroad from Headquarters to Mission or from Mission to Mission.
3. The entitled officers at present serving abroad and who had requested for bed and table linen prior to issue of the order for lumpsum grant but have not been supplied the same so far, will also be eligible to the grant subject to the condition that they have not completed half of their normal tenure at the present post on the date of issue of these orders. The decision in their cases will be taken after taking into account the date on which they were supplied bed and table linen either in full or in part.
4. The Head of posts and other entitled officers who happen to remain at the same post beyond the period of three years will not be eligible to the grant till they are posted to another Mission.
5. Other terms and conditions as indicated in above mentioned letter dated 15 Jun 1990 of this Ministry.
6. The expenditure will be debitible to the relevant Head of Defence Services Estimates.
