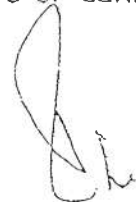

5. Separate category codes to monitor expenditure on capital procurement under the three streams, i.e., by Capital Acquisition Wing, under the delegated powers of the VCOAS, VCNS, DCAS & CISC and under the provisions of the aforesaid letters of 2007, 2008 & 2009, have already been allocated by the CGDA. The Service HQs and HQ IDS should therefore indicate the category codes alongwith the booking/expenditure heads in the contracts/Supply Orders. These category codes are as follows -

6. Capital items that were earlier being purchased from the capital budget following the capital procurement procedure cannot be purchased under the provisions of this government letter. Such items would continue to be purchased from the capital budget as per the procedure laid down in the DPP, as hithertofore. Civil works that are required to be carried out as per the Defence Works Procedure are also not covered by the provisions of this letter.

7. The provisions of this letter would be reviewed after two years or earlier if considered necessary.

Subject: Classification of expenditure

In supersession of earlier orders on the subject issued vide no. PC-11(1)/Bud.I/2007 dated 25.09.2007, 21.10.2008 & 23.11.2009, service-wise lists of items which are considered to be basically capital in nature but expenditure in respect of which was being booked to revenue heads have been identified afresh and it has been decided that expenditure in respect of these items shall be booked to the identified capital heads, subject to cost life criteria being met in individual cases. These items are listed in Appendices A to D to this letter.

2. In so far as motor vehicles are concerned it has been decided to dispense with the cost-life criterion and therefore expenditure on procurement of vehicles of all types irrespective of cost and life shall also be met from the capital head.

3. It has been decided that procedure as laid down in Defence Procurement Manual 2009; and further amendments thereto, will be followed for procurement of the identified items and the CFAs for sanctioning such procurements will be determined as per the extant delegation of financial powers for revenue procurement. However, off-sets shall not be applicable in respect of purchases under these orders.

4. The provisions of this letter are to be read in conjunction with other related orders on classification of expenditure between Revenue and Capital issued from time to time.
