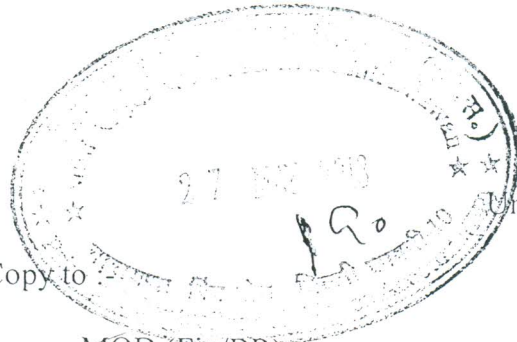
Sub: Levy of entry tax by various State Governments on entry of goods into the State
