I am directed to convey special delegation of financial powers for works related to Indo China Border Roads (ICBRs) and select operationally critical GS roads as approved by BRDB as per details in Annexure-I.

2. These financial delegations shall be applicable only for ICBRs and select operationally critical GS roads as approved by BRDB time to time.
3. The financial powers not mentioned specifically in this letter shall be as per the latest delegation of administrative and financial powers issued by the Ministry.
4. The above provisions will be implemented with immediate effect from the date of issue of this letter.
5. This issues with the concurrence of Ministry of Defence (Fin/BR) vide their ID file NO 19(3) BRS/14/364/BR/14 dated 14th Nov 2014.

2. Delinking ICBRs from AWP: AWP for BRO may be finalized by BRDB with ceiling prescribed for ICBRs jobs. Detail of ICBRs jobs shall be included in AWP by DGBR within the prescribed ceiling. DGBR shall finalize AWP for ICBRs and furnish a report to BRDB.

3. Repeat Supply Orders for purchase of Vehicles / Equipment/ Plant: Repeat supply orders upto 100% of the quantity and valid for two years from date of placing supply orders. Provision to add escalation to original price during second year based on WPI. This option shall be exercised on case to case basis in exceptional cases for reasons to be recorded in writing. RFPs shall be approved by CFA in such cases.
