No.PAO/GREF/CC/AROB/24-IV dt.23.4.2018.

Kindly refer to main office letter cited under reference through which it has been informed that the competent authority has decided to continue operation of code head 018/65 till 31st May 2018 and existing practice for making GPF Ty. Advance will continue till 31st May 2018 by AO (P/TF) concerned. In order to reducing of operation of Code Head 018/65, this office has already implemented CMP payment of Final Settlement cases w.e.f. 13.4.2018.

Subsequently, as desired by PCDA Sir during his last visit that Payment of GPF Ty. Advance also to be paid by this office accordingly necessary provision in Skylark for payment of GPF Ty. Advance has now been made. The necessary data for payment of Ty. Advance will be imported through PAO's GREF website for which this office will provide login ID to the all AO(P/TF) offices. Necessary changes in PAO's website have also been completed and it is under security audit by NIC and it will take 10 to 20 days. Till completion of Security audit, if agreed by Main office, we may call for documents for payment of GPF Ty. Advance from AO Offices by Speed Post.

In this connection, a copy of new features to be added in PAO's Website and proposed SOP for payment of GPF Ty. Advance and other activity is attached herewith as ANNEXURE-A, ANNEXURE-B and ANNEXURE-C for necessary approval of Competent Authority.

After receipt of approval from Main office, complete guideline and instructions thereof will be issued to all AO offices for forwarding of data for payment of GPF Ty. Advance and other activity to this office through PAO's Website.

Further, it is also brought to the notice of Main office that for providing of Login ID and Password to the AO office and Unit, this office has sought the Mobile Numbers of the official of the AO offices and unit to send OTP vide this office letter No.PAO/GREF/EDP/Website dt.23.4.2018 (copy enclosed) but only 09 AO offices (AO44TF, AO764TF, AO756TF, AO21TF, AO32TF, AO14TF, AO(P)Beacon, AO (P) Vartak and AOEBW have provided details to this office. Therefore, it is requested to instruct all AO office to provide necessary data (i.e. Mobile Number and Name of Data uploader and Authorizer) immediately to this office so that we can implement the same smoothly in prescribed time.
