**Subject : Implementation of One rank One pension for Defence pensioners
and family pensioners by Treasury Offices.**

It is intimated that GOI, MOD have issued order vide their letter No.12(1)/2014-D(Pension/Policy)- Part-II dated 03.02.2016 for grant of One rank One pension (OROP) for pre 01.07.2014 retirees of Armed forces commissioned offices, JCO/OR and their families which are to be made effective from 01.07.2014.

In this connection a DO letter (copy enclosed) received from Addl. CGDA requesting to interact with the respective Directorate of treasuries falling within the Jurisdiction of different organizations seeking to have the consolidated status on revision of pensionary benefits to Defence personnel under OROP scheme. As timely and correct payment of pension to Ex-serviceman is a high priority agenda for Govt. which is directly monitored by the Prime Minister as well as Defence Minister, you are requested to liaise with the Directorate of treasuries for status on the revision of pension under OROP scheme.

A report to this effect may please be rendered duly completed the enclosed format to this office by 20.12.2016 for further appraisal of the position of the same to HQrs. Office.

Dear Nayak,

I am writing to you in the context of implementation of OROP scheme announced by Government of India in February 2016, especially with regard to the State Treasuries spread across the country.

2. As you are aware, the Ministry of Defence, Government of India vide notification No 12(1)/2014/D(Pen/Policy)-Part-II dated 7.11.2015 and Order of same number dated 3.2.2016 have implemented the revision of pensionary benefits under OROP scheme to retired Defence personnel. Subsequently, PCDA (P) Allahabad vide Circular No. 555 dated 4.2.2016 issued payment instructions to all Pension Disbursing Agencies (PDAs) including Treasuries for revision of pensionary benefits to retired Defence personnel under OROP scheme. This HQrs Office has separately written to the Principle Secretary (Finance)/ Directorate of Treasuries of all State Governments (copy of letter dated 11.4.2016 attached) with a request to revise pensionary benefits under the OROP scheme and to render a consolidated status report of all Treasury Offices under their jurisdictions on the revision of pensionary benefits. However, barring a few Directorate of Treasuries (viz Gujrat, Karnataka, Chattisgarh & Mizoram), the response from the Directorate of State Treasuries has not been very good; as a result of which the HQrs Office has not been able to complete the status report particularly with regard to those Defence pensioners who are drawing pensionary benefits from the State Treasury Offices.

3. I would like to mention that the status on revision of pensionary benefits to retired Defence personnel under the OROP scheme is being monitored personally at the level of Hon'ble RM and PMO very closely and a weekly report on the status of revision of pension is being collated by the HQrs Office and rendered to the Ministry as well as to the PMO on a regular basis. However, due to non-submission of status report from the treasuries, complete picture on the revision of pension under OROP scheme is not possible.

I would, therefore, request you to depute a Senior Officer from your office(s) to interact with the respective Directorate of Treasuries falling within your jurisdiction to seek consolidated latest status on revision of pensionary benefits to Defence personnel under the OROP scheme in the enclosed format. I would expect that a report in this regard after liaising with the State Authorities may be rendered to me latest by 22.12.2016.
