**Subject:** Stepping up of pay for removal of anomalies in pay fixation under RPR 1997-GREF Personnel.

On the face it appears that the pay anomaly has arisen due to grant of an additional increment to Shri Kishor Kumar in terms of MoF letter dated 19-03-2012, however, the anomaly appears to find its origin in notional pay fixation done w.e.f. 01-01-1996. The individuals were initially transited from 4<sup>th</sup> CPC to 5<sup>th</sup> CPC from pay scale of Rs 975-1540 to pay scale of Rs 3200-4900 w.e.f. 01-01-1996, but later on after implementation of 6<sup>th</sup> CPC recommendations they were transited from Rs 975-1540 to Rs 5000-8000 notionally w.e.f. 01-01-1996. It appears that some anomaly might have been created at the time of this notional pay fixation. It is requested that notional pay fixation w.e.f. 01-01-1996 of both the individuals may be checked. In case there is any anomaly during the span of notional pay fixation between 01-01-1996 and 31-12-2005, please examine whether the proviso 2 of Rule 8 of CCS (RP) Rules 1997 can be applied to sort out the matter and take action accordingly to resolve the issue. If still required, your views on this aspect may be intimated for better appreciation of the case.
