Sub: Extension of LTC facilities to Defence Industrial Employees

A reference was received from MES Employee's Union Pune wherein a doubt has been raised that whether LTC claims on account of IRCTC packages are to be restricted to the shortest route from HQrs to the declared place of visit or the entire tour package is to be reimbursed.

2. The matter was referred to MoD for clarification. MoD D (Civ-II) in consultation with DoPT has clarified vide MoD ID No. 11(!)/2013/D(Civ-II) dated: 14.07.2014, that "reimbursement in such cases will be in accordance with Gov Decision (i) and GID (2) under Rule 13 of CCS (LTC) Rules 1988, whichever is applicable".



Subject: Extension of LTC facilities to Defence Industrial Employees.

CGDA may please refer to their LO No. ADIV/LTC/III dated 26 March, 2014 regarding non-payment of LTC claims of MES employees.

2. The matter has been examined in consultation with DOP&T. As per DoPT OM dated 26.03.2008, tours conducted by IRCTC will qualify for the purpose of availing LTC subject to certain conditions. However, nowhere in the aforesaid OM it has been mentioned that in such cases travel charges will be fully reimbursable. As per CCS(LTC) Rules, reimbursement under Leave Travel Concession Scheme is allowed on the basis of point to point journey through the shortest direct route between two places (HQ to the declared place of visit). Hence, reimbursement in such cases will be in accordance with GOI Decision (1) and GID(2) under Rule 13 of CCS(LTC) Rules 1988, whichever is applicable.
