



Subject :- Doubling of existing rate of Payment of Hospital Patient Care Allowance/ Patient Care Allowances to eligible Group 'C' and 'D' (Non Ministerial) employees of the Armed Forces Hospitals/Medical Establishments w.e.f. 01.9.2008.

Sir,

I am directed to refer to this Ministry's letter No.7/1/2000-D(Med) dated 17th November, 2005 wherein provisions of Govt. of India, Ministry of Health & Family Welfare's (MOH&FW) letter No.Z-28015/24/2001-H dated 4th February, 2004 and 05.05.2005 were extended to the eligible Group 'C' and 'D' (Non Ministerial) employees of Armed Forces Hospitals/Medical Establishments with effect from 08.11.1995 and to convey that the President is pleased to extend the provisions of Ministry of Health & Family Welfare's OM No.Z-28015/119/2012-H dated 17th December, 2012 for doubling the existing rate of payment of HPCA/PCA to all eligible Group 'C' & 'D' (Non Ministerial) employees of Armed Forces Hospitals/Medical Establishments with effect from 01.9.2008. The amount of HPCA/PCA would be automatically raised by 25% every time the Dearness Allowance on the revised pay structure goes up by 50%. This is subject to the following terms & conditions:-

- (i) HPCA/PCA may be admissible in case the individual proceeds on leave/ training for less than one calendar month;
 - (ii) HPCA/PCA may not be admissible in case the individual proceeds on leave training for more than one calendar month;
 - (iii) HPCA/PCA should not be admissible in case of unauthorized leave.
2. The expenditure involved will be met out of the 'Pay and Allowances' Heads of respective services.
3. This issues with the concurrence of the Defence Finance vide their ID No. 115 /AG/PB dated 18.7.2013.
