Sir,

Reference is invited to this Sectt Office Order of even number dated 23 November 2012 regarding revision of Bhutan Compensatory Allowance.

2. The condition mentioned on page 2 of the Office Order of even number dated 23 November 2012 which reads as : "[Grade Pay at initial appointment should be considered only and not after MACPs. For example an Assistant-level official who may be drawing a GP of Rs. 4800/-/Rs. 5400/-/Rs. 6600/- should be placed in sixth category only]" stands deleted. It is clarified that BCA should be fixed on the basis of present Grade Pay and not at the basis of initial Grade Pay.

3. This issues with the concurrence of Ministry of Defence (Fin/BR) vide their ID No. 2 (7)/93/BRS (1324/13) dated 17<sup>th</sup> December 2013.
