

Subject:- Adjustment of TBO

The AO GREF CENTRE has again pointed out that some of the Tax Forces are not responding the debit raised citing the following reasons:

1. Personnel posted out to other units.
2. Amount being less than 1 lakh.
3. For want of pre-acceptance.

In view of the above you are directed not to return any TBOs raised by AC GREF Centre, merely on the grounds cited above. You are also directed to respond TBO in full and then raise debit against any other concerned Accounts Office, if certain amount pertains to that office, without involving AO, GREF Centre, as that office has no budget allocation for adjustment of Pay and Allowances of GREF recruits as per existing policy of the DGBR, such expenditure is to be borne by the units to which the recruits are posted.

Main office Circular No. 59, dated: 18-01-2005 and letter of even No. dated 10-03-2010 are also relevant on the above subject.
